SUPERINTENDENT NOTES by Jack D. Moles



Certified State Aid figures for the 2014-15 school year were recently released by the Nebraska Department of Education. State Aid will not be kind to Johnson County Central again, as we will lose about \$123,000 next year as

compared to this year. This equates to over half of the State Aid we received this year. The \$107,383 we will receive is actually a little more than I had originally planned on, but only slightly. The total is the least amount we will have received as a district. This is a direction I have been foretelling for several years now.

The State Aid formula, while quite complicated, is based on a simple theory that goes like this: NEEDS-RESOURCES=STATE AID. This means that the State determines what a school's needs are based on many factors. Then they figure what other resources, mainly local, are available to the district. Subtract the resources from the needs and in theory that school's State Aid is determined. A school that substantially grows its budget while not seeing much of an increase in local funding in theory should expect to see more State Aid. A district that does not grow its budget much, but sees a larger increase in local resources in theory will see a drop off in State Aid.

Another part of the formula is that the spending of each district is compared to that of like-sized districts to help determine needs. An individual school district's comparison group is made up of the ten school districts smaller and the ten that are larger in terms of formula students. Thus, every school district will have a different comparison group. In the case of JCC, the group goes as small as Superior (457 formula students) to Winnebago (555 formula students). When comparing Adjusted General Fund Operating Expenditures and Adjusted General Fund Operating Expenditures Per Formula Student (the two figures used by the State), JCC is a below average spender. In Adjusted General Fund Operating Expenditures, JCC spent \$4,942,448 as compared to a group average of \$5,220,557, or almost \$300,000 less. In the area of spending per student, JCC spent \$9,501 as compared to a group of average of \$10,161, or \$660 less. Thus, JCC's spending appears to be very much in line with the spending of schools of a similar size.

A trend that we are seeing in Nebraska school finance is that more and more schools are moving from being "equalized" districts to "non-equalized" districts. Equalized districts do not have enough resources and receive State Aid. Non-equalized districts are determined to have enough resources so they do not receive State Aid. For years the number of school districts who were non-equalized was in the 30-range, but has grown over the past few years. This year 114 school districts are classified as non-equalized and projections are that almost half of the schools (around 140) will become non-equalized in a matter of a few years. Much of this trend is being caused by rapidly escalating agricultural land valuations. My prediction has been that JCC will move into the non-equalized group but we are not there yet.

As we work through next year's budget, a question of timing makes efforts difficult. There are four "magic" dates that we have to look at when developing our budget, and in my opinion these dates are not in the proper alignment.

The first date is February 8. The Board of Education and the local teachers' group is required to complete negotiations by this date. They must do this without knowing what State Aid or local property valuations will be. Actually, they do not even know the staff that will be in place for the next year. In reality, the only "piece of the puzzle" that they have for the next school year is health insurance premiums.

The next date is April 10. This is the date that the State must inform schools what their State Aid will be for the following year. This date has jumped around quite a bit over the years. In my memory, the certification date has been as early as February 15 and as late as June 1 in given years.

The next date a district must look at is April 15. This is a date by which districts must inform certificated staff (i.e. teachers) whether there will be a "reduction in force (RIF)". If a school is going to look at using a RIF to help lower costs they must be in contact with staff members who could potentially be affected by a RIF. At our April Board of Education meeting, the Board did not take action to utilize reduction in force.

The fourth date is August 20. County Assessors are required to provide valuation certifications to school districts by this date. Notice that this date is over four months after the RIF date. Thus, in some years a district might not know either their State Aid or property valuations before having to make staffing decisions.

The main problem with all of this, of course, is how to put together a budget for the 2014-15school year. As in recent years it will again be tight. I have begun the process of working through this and will meet with the Board of Education's Budget Review Committee in the near future to discuss specific ways in which we can make this work. Many different angles will need to be looked at in reaching this goal.

GRADUATION

I would like to wish the graduating class good luck in their futures. This has been a class with many accomplishments. I will miss this group as their graduation will create a huge void in our school. I have certainly been proud to be associated with them.

This is the time of year that brings along many celebrations. I would like to urge our students and their parents to use good sense in the activities that sometimes go along with these celebrations. I am, of course, referring to alcohol use by students. Absolutely nothing good comes out of teenagers drinking. At best nothing negative happens to them. This is the time of year that I worry the most about the safety of our kids. I sincerely hope this worry is all for naught. Parents, please do your part in ensuring the safety of our students.

Middle School News by Principal Rich Bacon




Elementary Track & Field Day will be Friday, May 16th for grades 4, 5 & 6 starting at 12:30. Parents are invited to come watch the fun and games.

Summer school will be available again for Middle School students in need of credit recovery due to poor grades or attendance issues. Summer school will run every week, Monday through Thursday, from 8:00-12:00 during the month of June. The cost is \$50/class with each family capped at \$100. Students who are candidates for summer school will be contacted some time during the month of May.

As the end of the school year approaches, we'll need to turn our attention to the requirements students need to meet before they are allowed to leave for the summer. Each Middle School student will need to check out with the office on the last day of school, May 21st. Each student will receive a check out sheet. All teachers, coaches, and staff will need to sign the check out sheet before it can be turned in to the office. Before this checkout sheet can be signed, students will have to have all school materials (textbooks, library books, uniforms, equipment, padlocks, etc.) turned in, and all bills, fees, and fines must be paid. Any lost or damaged items will need to be paid for. Both their school locker and their gym locker will need to be cleaned out and all personal items must be taken home. Students will not receive their report cards until everything on their checkout sheet has been taken care of. Please have your child check on these items prior to the last day, so he/she doesn't have to make an extra trip back to school to get their checkout sheet signed. Also, any student who has been absent for more than the eight days allowed during second semester must make up that time in Saturday school before the last day of school.

Staying in Stride, or getting a leg up!

If your summer gets as busy as ours, it's hard to keep up with everything, let alone trying to get the kids to do anything academic. However, the summer can be a great time to help your student stay academically on track or to help them get caught up. The good news is, you don't have to hover over your child's shoulder to get it done either. Here are some ideas:

- 1. Download some apps on the device that practices some academic skills. There is no shortage of these. Let your child know that they can play games after they have spent a predetermined number of minutes practicing their academic skills.
- Reading. During softball, baseball, 4H or vacation road trips, have your child bring their

- books along (or device with books downloaded). When it's dark outside, encourage reading. The more they read, the more fluent they become. The more fluent they become, the more they comprehend. It's a cycle!
- 3. Also, when vacationing, bring maps or bring up Google Maps, and have your child follow where you are and where you're going. Have them identify landmarks. This will give them a great sense of Geography.
- 4. Have them practice buying items with cash. This will help them to identify the different bills and coins. It will also help them with their ability to figure out how much something costs, how much they have, and how much they should get in change.
- 5. Give them a job to earn a little cash. The sense of responsibility this brings

is rewarding in itself. Children love having their own money. And, they get an idea for what it takes to earn money to spend.

It is amazing how quickly a child can pick things up when they are taught by a loving adult, and they receive real world practice and application of their skills. Not only are they getting one -on-one attention from someone, they are getting it from the people they love most in their lives; their parents, grandparents and family. These experiences are priceless. If you could only see the pride and joy on your child's face when they puff out their chest and boast to the class what they learned from their special someone, you would see

2014-2015 ACT TESTING DATES AND REGISTRATION:

To help with planning for next year, ACT testing dates and registration deadlines for the 2014-2015 school year are listed below. Please notice that the registration deadline for the September test date is the first Friday after school begins.

Reminder – students must electronically submit a photo with the application and the admission ticket will have the student's picture printed on it. When students take the test, they must have photo identification so test proctors can match the picture to their printed admission ticket.

All students must also indicate the school they attend when registering. Johnson County Central High School's **school code number** is **282 319**.

Students may register online at <u>www.actstudent.org</u>. Online registration is possible 24/7 on any computer connected to the internet. A MasterCard or VISA must be used to pay fees online. (Fee Waivers are available for juniors and seniors who qualify- see Mrs. Moles for waiver eligibility).

The www.actstudent.org site also offers FREE practice test questions, FREE ACT Question of the Day, FREE Test tips, FREE "Preparing for the ACT" booklet in PDF format, and FREE Test Descriptions. The ACT Question of the Day may be a painless way for students to prepare for the type of questions on the ACT during the summer!

PERU STATE COLLEGE EARLY ENTRY ONLINE CLASS ENROLLMENT:

Juniors and seniors of 2014-2015 have until August 1, 2014 to enroll in online courses offered through Peru State College in the Fall 2014 (August 18-December 12). Online courses available and credits available are: English Composition (3), American History Before 1865 (3), Introduction to Psychology (3), Principles of Sociology (3), and Teacher Education: Principles & Practicum (3). Please see Mrs. Moles for more information and enrollment forms if interested in taking an online class through PSC this fall. Enrolling early will allow students to become familiar with the online format and purchase the required text before classes begin on August 18.

American History Before 1865 and Introduction to Psychology will also be offered in the traditional classroom format at Johnson County Central. Students may enroll shortly after school begins.



Elementary Guidance

The last lessons in the Second Step program deal with problem-solving. Elementary students learned the 4 steps to problem solving:



- Say the problem (without blame).
- 2. Think of solutions (that are safe and respectful).
- 3. Explore consequences.
- 4. Pick the best solution (for all people that are involved). Students practiced these problem-solving steps by creating scenarios which they had to solve a problem. The upper grades made posters to explain the steps they would take to solve their problems.

Problem-solving is an important skill in school and in life.

Students need to feel confident that they can handle situations that are not always easy. These lessons provided students with the tools to make a plan and solve their problems for themselves.

In addition to problem-solving, we have also been working on the difference between "include" and "exclude." Students did role-playing to practice how to ask someone to play if they were standing by themselves, how to introduce themselves and others and also how to accept invitations. These role-playing activities reinforced the importance of empathy, which is a skill taught throughout the school year. Empathy, the ability to feel or understand what someone else is feeling or thinking, is an important skill for students to use in all areas of life.

Grades K-2 will continue into the spring with lessons encouraging kindness and empathy as well as reflection on individual strengths and future plans in their "All About Me" books. Students in grades 3-5 will learn about Internet Safety and Digital Footprints as well as transitional information as they prepare for the following grade.

Middle School

The middle school weekly lessons also focus on empathy and treating others well. Students need to understand that these behaviors carry over into online activities, not just when they are talking to someone face-to-face. In the fall, students at the Cook site grades 5-8 participated in a presentation by Karen Haase, an attorney, about benefits and consequences of the Internet and Digital Citizenship. This spring, we are continuing with online educational lessons that have focused on Digital Footprints, the legacy one leaves by their posts and comments on the Internet. Did you know that 90% of college campuses have an officer assigned to search these Internet venues: Facebook, Twitter, Instagram, Pinterest, Vine, Snapchat, Edmodo, Blackboard, Skitch, and Evernote among others. Students need to be aware of possible consequences to their online behaviors, the trail they are creating which is referred to as their Digital Footprints.



Topics that will be covered with the Internet Safety lessons include; Digital Footprints, When Are You Sharing Too Much? Cyber bullying, and Online Predators; Who is on the Other End of the Computer?

These lessons combine facts and information as well as short videos to reinforce appropriate online behaviors. The lessons remind students, there is no delete button-once something is posted on the Internet-it is there forever. The questions we ask students to ponder include; what legacy are you creating by your Internet behaviors? How could your postings and comments affect your future? What impression are you making?

Students are growing up in a brave new world, very different from the one in which their teachers and parents were raised. It is important to educate them about Internet Safety so they can be informed Digital Citizens.

ANNUAL REPORT APRIL 2014

This annual report for the Johnson County Central Public Schools district was compiled as one of the requirements of the Nebraska School Accreditation Standards to be met in Nebraska Department of Education, Rule 10. It is distributed annually via the school district newsletter to all school patrons.

SCHOOL DISTRICT GENERAL INFORMATION

History

Johnson County Central Public Schools came into existence as a result of a merger between Tecumseh Public Schools and Nemaha Valley Schools in May, 2007.

Accreditation

Johnson County Central is fully accredited by the Nebraska Department of Education. Each fall our school completes reports to indicate accreditation standards have been met. A thorough self-study involving school staff, students and district patrons must be completed to meet Rule 10 Requirements. The School Improvement Team is currently working on the self-study. Johnson County Central also has attained North Central Accreditation.

Activities

Membership is maintained in the Nebraska School Activities Association (NSAA) which governs Nebraska high school extra-curricular activities. NSAA assigns schools to various classifications for competition based on each member school's fall boy-girl enrollment count in grades 9-11 and the number of schools involved in each activity. This year NSAA has placed Johnson County Central in the following classifications: Track, Speech, Play Production, Music, Softball, Golf, Cross Country, and Wrestling (Class C); and Football, Basketball, Volleyball (Class C-1).

Johnson County Central is a member of the East Central Nebraska Conference. Other members include Conestoga, East Butler, Elmwood-Murdock, Freeman, Louisville, Malcolm, Mead, Palmyra, Weeping Water, and Yutan. Auburn will join the ECNC in the 2014-15 school year. JCC also takes part in MUDECAS activities. Other member schools in MUDECAS include Bruning-Davenport, Diller-Odell, Exeter-Milligan, Falls City Sacred Heart, Freeman, HTRS, Johnson-Brock, Lewiston, Lourdes Central Catholic, Meridian, Parkview Christian, Palmyra, Pawnee City, Southern, and Sterling,

Size of District

The district encompasses 296.7 square miles with 188.2 square miles in Johnson County; 8.2 square miles in Nemaha County; 91.5 square miles in Otoe County; and 8.8 square miles in Pawnee County.

Facilities

Three main facilities are utilized by the district. The high school is located in Tecumseh. Also located in Tecumseh is a PK-3 elementary facility. In Cook a PK/4-8 facility is utilized.

The elementary building in Tecumseh was completed in 1931. The high school building was constructed in 1964-65. The main part of the building in Cook was finished in 1958, with additions completed in 1999.

Most asbestos was removed from all school buildings many years ago. Except for some non-friable asbestos in floor tile and in above ceiling duct work, the buildings are asbestos free. Pipe insulation that contains asbestos in the high school building has been coated according to regulations.

Faculty/Support Staff

The students of Johnson County Central are served by 41.75 teachers, 5 special education teachers, two full time Title 1 Reading and Mathematics teachers, two Library/Media specialists, two Guidance Counselors, one Alternative Education teacher, three building Principals, one Superintendent of Schools and the following support staff members: 5 bus drivers, 1 full-time head cook and 6 part-time cooks, one full-time maintenance person, four full-time secretaries, 15 teacher aides, one bookkeeper, one technology aide, and 1.5 school nurse. Johnson County Central contacts with an outside source for custodial services.

School Board

The school district is being governed by a six member Board of Education. Each member's term of office is four years and members are elected at-large. Members of the current Board of Education are: Susan Borcher, Mike Gerdes, Teresa Goracke, Barb Gottula, Greg Hunzeker, and Mike Remund. Board officers for 2014 are Greg Hunzeker (president), Susan Borcher (vice-president), and Barb Gottula (treasurer). Superintendent Jack Moles serves as the Board secretary, while Laurie Badertscher is the appointed board recording secretary.

Education in Johnson County Central must serve the individual pupil in the light of his/her capacities and abilities and provide a suitable and well-balanced learning environment in the areas of physical, mental, emotional, cultural, social, moral, and spiritual maturity.

The school shall be concerned with students acquiring knowledge in their subjects, but also taking into consideration the interest of the children themselves, their growth, interests, needs and unique personalities.

It is the primary responsibility of Johnson County Central to provide pupils the nature and meaning of democratic values and to help the children develop a loyalty to those values through personal commitments.
