Superintendent Rother provided documents with reference to work that has been completed on real estate legally described as Outlot D, Shawnee Ridge Addition to the City of Tecumseh, Johnson County, Nebraska as follows:

Principal Lester provided information to the Board of Education regarding the Nemaha Natural Resources Hazard Mitigation Plan 2020.

WHEREAS, the Federal Disaster Mitigation Act of 2000 was signed in to law on October 30, 2000, placing new emphasis on state and local mitigation planning for natural hazards and requiring communities to adopt a hazard mitigation action plan to be eligible for pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, a Multi-Jurisdictional Hazard Mitigation Plan was prepared by the Nemaha Natural Resources District, with assistance from JEO Consulting Group, Inc.

WHEREAS, the purpose of the mitigation plan was to lessen the effects of disasters by increasing the disaster resistance of the counties and participating jurisdictions located within the planning boundary by identifying the hazards that affect the district of Johnson County Cenetral Public Schools, and prioritize mitigation strategies to reduce potential loss of life and property damage from those hazards, and

WHEREAS, FEMA regulations require documentation that the plan has been formally adopted by the governing body of <u>Johnson County Central Public Schools</u> in the form of a resolution and further requesting approval of the plan at the Federal Level; and

NOW, THEREFORE, the Johnson County Central Public Schools Board of Educaiton does herewith adopt the Nemaha Natural Resources Hazard Mitigation Plan 2020 in its entirety on the 13th day of January 2021.
