The Johnson County School District No. 0050 Board of Education met in regular session at 7:50 p.m. on Wednesday, September 9, 2015, in the media center in Cook. A current copy of the agenda was available for inspection in the office of the Superintendent prior to the meeting. President Greg Hunzeker opened the meeting by announcing that the Open Meetings Act rules were posted.

A motion was made by Goracke and seconded by Borcher to approve the property tax request resolution as follows:

2015-16 TAX REQUEST RESOLUTION FOR JOHNSON COUNTY CENTRAL PUBLIC SCHOOL DISTRICT (49-0050)

WHEREAS, public notice was given at least five days in advance of a Special Public Hearing called for the purpose of discussing and approving or modifying the District's Tax Requests for the 2015-16 school fiscal year for the General Fund, Bond Fund, and Special Building Fund of Johnson County Central Public School School District (49-0050); and,

WHEREAS, such Special Public Hearing was held before the Board of Education (hereinafter "the Board") of Johnson County Central Public School District (49-0050) (hereinafter "the District") at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and,

WHEREAS, the Board provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and,

WHEREAS, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2014-15 school fiscal year.

NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is set at \$5,879,880.75; (2) the Tax Request for the Bond Fund should be, and hereby is set at \$285,606.06; and (3) the Tax Request for the Special Building Fund should be, and hereby is set at \$206,540.40.

It is so moved by Teresa Goracke and seconded by Sue Borcher this 9thth day of September, 2015.
