

I wish these seven individuals much luck and happiness in the future. Each had a large, positive impact on our school and we are very appreciative. Our school was a better school because they were part of it.

#### **SUMMER MONTHS**

Students, and probably parents, are ready for the relaxed atmosphere of summer. They get the opportunity to get out of the school routine and not be as tied to timelines. However, a complete abandonment of routine, academics, and discipline can be very counter-productive as kids near the return to school in August. For that purpose, I would like to pass on a few tips that may help students and parents to deal with summer:

- Do keep some routines in place. The most obvious in preparation for the beginning of a new school year would be to maintain regular bedtime hours and to have those hours close to what the school year hours that are normally maintained. Other routines that should be maintained might be chores and regular meal times.
- Expect your child to maintain summer reading and academic pursuits. Carl Pickhardt, a psychologist who is a regular contributor to Psychology Today, suggests that four hours a week is a very attainable goal for academics. Do encourage your child to read grade/age appropriate materials regularly during the summer.
- Limit the hours of screen time (TV, computer games, computers and iPads, cell phones). Pickhardt recommends that this time be limited to no more than 15 hours per week during the summer. Most appropriately, he said, "A kid playing by himself in a dark room—I just don't think that should be the summer experience." I also read an article recently in which the writer said that her son was never a big reader until she limited the amount of screen time he had. Once he had to fill his time in another way he started to read more. It would be a good strategy to set the exact times in a given day that screen time can be accessed.
- Encourage your child to get outside for exercise, play, and exploration every day if possible. Mental improvement is needed, but so is the too often overlooked physical improvement.
- One strategy to try would be to encourage your child to attempt a new hobby. This would serve to hold his/her interest, but also to continue to learn in an active manner.
- Take advantage of camps. These can be in many forms: Vacation Bible School, sports camps, academic camps, or 4-H camps for example. All serve to provide great learning experiences, opportunities to build on skills, and learn to interact with others.
- If your child is in high school and expects to play sports during the school year, expect him/her to take part in the camps and leagues that are available, as well as getting into the weight room or conditioning program on a regular basis. The days of competing on a high enough level without taking part in summer activities really disappeared many years ago. The teams that are the most competitive do not depend on natural ability alone. I know that our opposing schools will have their athletes involved during the summer—ours should be as well. There are regular weight room hours in which coaches are present. If you as a parent do not know those hours I recommend finding out what they are.
- Provide short day trips as learning experiences and family-bonding opportunities for your child. There are many great area sites that would provide for fun-filled and educational opportunities. Examples include Henry Doorly Zoo in Omaha, Homestead National Monument in Beatrice, Arbor Lodge and the Lewis and Clark Center in Nebraska City, Morrill Hall and the Children's Museum in Lincoln, and the Air and Space Museum in Ashland.

I think summer should be a fun time for kids, but should not be a time that they abandon everything to do with school. I especially encourage them to have fun with their parents.

#### ANNUAL REPORT MAY, 2018

This annual report for the Johnson County Central Public Schools district was compiled as one of the requirements of the Nebraska School Accreditation Standards to be met in Nebraska Department of Education, Rule 10. It is distributed annually via the school district newsletter to all school patrons.

#### SCHOOL DISTRICT GENERAL INFORMATION

#### History

Johnson County Central Public Schools came into existence as a result of a merger between Tecumseh Public Schools and Nemaha Valley Schools in May, 2007.

#### Accreditation

Johnson County Central is fully accredited by the Nebraska Department of Education. Each fall our school completes reports to indicate accreditation standards have been met. A thorough self-study involving school staff, students and district patrons must be completed to meet Rule 10 Requirements. The School Improvement Team is currently working on the self-study. Johnson County Central also has attained Advanced Accreditation.

#### **Activities**

Membership is maintained in the Nebraska School Activities Association (NSAA) which governs Nebraska high school extra-curricular activities. NSAA assigns schools to various classifications for competition based on each member school's fall boy-girl enrollment count in grades 9-11 and the number of schools involved in each activity. This year NSAA has placed Johnson County Central in the following classifications: Track, Music, Golf, and Wrestling (Class C); and Football, Basketball, Volleyball, Play Production and Speech (Class C-1). JCC is Class D in Cross Country. JCC participates in NSAA-sponsored Unified Bowling. JCC also co-ops Soccer with Nebraska City in Class B.

Johnson County Central is a member of the East Central Nebraska Conference. Other members include Auburn, Conestoga, Elmwood-Murdock, Freeman, Louisville, Malcolm, Mead, Palmyra, Weeping Water, and Yutan. JCC also takes part in MUDECAS activities. Other member schools in MUDECAS include Bruning-Davenport, Diller-Odell, Exeter-Milligan, Falls City Sacred Heart, Freeman, HTRS, Johnson-Brock, Lewiston, Meridian, Parkview Christian, Palmyra, Pawnee City, Southern, Sterling and Tri-County,

#### Size of District

The district encompasses 296.7 square miles with 188.2 square miles in Johnson County; 8.2 square miles in Nemaha County; 91.5 square miles in Otoe County; and 8.8 square miles in Pawnee County.

#### **Facilities**

Three main facilities are utilized by the district. The high school is located in Tecumseh. Also located in Tecumseh is a PK-3 elementary facility. In Cook a PK/4-8 facility is utilized.

The elementary building in Tecumseh was completed in 1931. The high school building was constructed in 1964-65. The main part of the building in Cook was finished in 1958, with additions completed in 1999.

Most asbestos was removed from all school buildings many years ago. Except for some non-friable asbestos in floor tile and in above ceiling duct work, the buildings are asbestos free. Pipe insulation that contains asbestos in the high school building has been coated according to regulations.

#### Faculty/Support Staff

The students of Johnson County Central are served by 43 teachers, six special education teachers, two full time Title 1 Reading and Mathematics teachers, one English Language Learner teacher, one Library/Media specialist, two Guidance Counselors, one Alternative Education teacher, three building Principals, one Superintendent of Schools and the following support staff members: four bus drivers, one full-time head cook and five part-time kitchen helpers, two full-time maintenance persons, five full-time secretaries, 15 teacher aides, one Business Manager, one technology aide, and one school nurse. Johnson County Central contacts with an outside source for custodial services.

#### **School Board**

The school district is being governed by a six member Board of Education. Each member's term of office is four years and members are elected at-large. Members of the current Board of Education are: Arlin Beethe, Susan Borcher, Teresa Goracke, Greg Hunzeker, Rebecca Plager, and Kim Wellensiek. Board officers for 2018 are Greg Hunzeker (president), Susan Borcher (vice-president), and Kim Wellensiek (treasurer). Superintendent Jack Moles serves as the Board secretary, while Laurie Badertscher is the appointed board recording secretary.

#### **Strategic Planning/Mission Statement**

The mission statement of the school is: JCC: Journey of Excellence; Creating Lifelong Learners; Citizens for Tomorrow

The following governing beliefs have been adopted by the school:

Demonstrate exceptional educational instruction and learning.

Present a safe and drug-free setting that fosters the desire to learn.

Encourage progressive relevant student involvement.

Respect the contributions of all.

Integrate technology throughout the curriculum.

Focus on developing problem solvers in the classroom.

Stress global perspective and the appreciation of diversity.

Promote the value of the arts and extracurricular endeavors as integral parts of the curriculum.

Prepare students to contribute positively in the family, school, community and the world.

Instruct and demonstrate respect for the environment.

Establish a partnership of service between school and community.

#### **School Improvement**

Johnson County Central Public Schools participates in the Nebraska Frameworks school improvement process. The school improvement goal is as follows:

"Johnson County Central Public Schools will improve reading comprehension through the direct and explicit teaching of vocabulary."

In the spring of 2016 Johnson County Central hosted an AdvancEd external visitation team. The team surveyed the work of the district toward meeting the school improvement goal and also provided suggestions for working toward the goal.

#### **Instructional Goals and Objectives**

The primary goals and objectives of the Johnson County Central Public Schools shall be to provide all the children of the district with the best education possible, wherein each may develop wholesome attitudes, ideals, and concepts for better living in our democracy.

Education in Johnson County Central must serve the individual pupil in the light of his/her capacities and abilities and provide a suitable and well balanced learning environment in the areas of physical, mental, emotional, cultural, social, moral, and spiritual maturity.

The school shall be concerned with students acquiring knowledge in their subjects, but also taking into consideration the interest of the children themselves, their growth, interests, needs and unique personalities.

It is the primary responsibility of Johnson County Central to provide pupils the nature and meaning of democratic values and to help the children develop a loyalty to those values through personal commitments.

The participating student and one of his/her parents or guardians must sign the certificate of consent and turn this certificate into the school office. By signing this consent form parents and students acknowledge that they understand there are risks involved in any activity. This parental consent form must be on file at school for every student who participates in NSAA activities.


Each student, grades 7-12, who expects to participate in athletic contests shall present to the superintendent, principal, or school representative once each year, before actual participation in any interschool sport, a physician's certificate on a form recommended by the NSAA that he/she is physically fit for athletic participation. This physical examination must be given during the school year in which the student participates or during the summer vacation period which precedes the school year in which the individual participates. Also, all incoming 7<sup>th</sup> graders, freshmen and juniors must complete the ImPact Concussion test to establish a baseline in the event of a head injury. This test will be conducted by school officials and must be done before an athlete is allowed to practice or participate in a contact sport (football, volleyball, softball, basketball, wrestling, jumping events in track & field).

Parental consent forms were included with each student's report cards and physical evaluation forms can be picked up in the office at both sites. Please contact the school if you need either of these forms. All athletes who plan to participate in a fall sport need to take care of this prior to the beginning of fall practice on August 6, 2018.

Middle School is a critical step in a student's education. It presents new changes and challenges. We hope to help make this a smooth transition with the Fall Walk-Through by allowing students to see their schedules, find their rooms and lockers, and meet with their teachers. This time will also allow the parents to see what is expected of their children in each class regarding homework, lecture notes, deadlines, note taking, etc.

The Fall Walk-Through will begin at 6:00 pm in the commons area where students will receive their 2018 - 2019 schedules as well as forms to be completed. #### FOOD THAT'S IN WHEN SCHOOL IS OUT

**Johnson County Central Public Schools** is working to make sure that no child, goes hungry when school is closed this summer. Over 50% of children in the Johnson County Central Public Schools receive free or reduced-price meals during the school year, but many of these children do not get enough to eat when school is out. The Summer Food Service Program (SFSP) ensures that low-income children continue to grow and learn during the summer.

The Summer Food Service Program, sponsored by the U.S. Department of Agriculture, is the largest federal resource available for local programs that combine meal time with recreational and educational activities.

Superintendent Jack Moles and School Food Service Director Joann Gadeken recognizes the need for the program in the Johnson County Central Public Schools.

"Many of our children who rely on school breakfast and lunch during the school year do not have the energy they need during the summer. That's where we come in, by providing nutritious meals and activities to keep kids nourished and engaged."

"Our responsibility to kids doesn't end when school lets out. Kids who get enough to eat and have safe activities to participate in during the summer are less likely to get into trouble. Our summer meals program is a building block in the community for healthy, happy kids who are ready to learn."

The Summer Food Service Program for Children is a federally funded program operated nationally by the U.S. Department of Agriculture (USDA) and administered by a State Agency.

Eligible sponsors such as non-profit organizations, schools and local governments serve nutritious meals free to 18mo to 18 year old children during the summer months. Summer programs are located at approved sites that are either in low-income areas or serve a group of children, most of whom are low-income.

Our Summer Food Service Program for Children will Start, Monday June 4 through July 26. Monday through Thursday (NO FRIDAY'S OR HOLIDAY'S).
