From the Superintendent May 2020

Greetings!!!



Well, other than that, Mrs. Lincoln, how was the play? By now I hope that everyone is getting an opportunity to adjust to the rhythm of educational life as we know it in the Pandemic atmosphere. Let's hope that the rhythm gets a new beat before long and we can get back to some more familiar normalcy, but the prospects don't look good for a while.

Again, I am so proud of the entire staff in how they are adapting and still getting valuable things done with students and our families. We still continue to provide lunches either picked up at school or delivered to homes so that our students can maintain access to healthy meals. Our staff have all been rock stars to organize and work through the details of these services as well as instructional services. It is quite an experience and I think we will all look back at this time with a sense of pride.

Things seem to still be changing regularly about how we might be able to open up things for either the summer or next fall. The only thing that we know for sure is that we will not be able to return to school activities as normal until after May 31. With the latest recommendation from the Governor and Local Health Care leaders, it looks like that will extend through the summer until August 1. The word we just got yesterday indicated that no schools should plan any type of traditional Graduation gathering until July or August. That pretty well shuts down everything we would normally do over the summer. Now the better question will be: "What does next fall look like for opening school??"

That is going to be dependent on what the statistics about this thing reveal and if we see a slowdown of the spread. It looks like the President is recommending a reopening of our economy on a state-by-state basis with a graduated scale. That could mean that the gathering limitation could move from 10 to 30, and then to 50, etc. He has affirmed, however, that the Governors of each state will be the authorities establishing what a re-entry looks like. It will serve us all well to have put some thought into this in the next weeks to be prepared.

Some important notes for everyone:

1. We will be ending our instruction with students on May 15 instead of the 21st. We brought the idea to the Board of Education that ending instruction on the 15th for students would allow for doing a number of things that would bring more value to the use of our time. Our staff, however, will fulfill their contract days by working until May 22 as originally scheduled. We believe that the ability to debrief about what has happened to us over the COVID-19 period and plan for what we will do when we can get students back into our buildings makes more sense to better use the time available. Over the next few weeks we will be seeking some input regarding how to best use that time, and we have already alerted ESU 4 Staff to be prepared to support our needs.

2. In the digital age of instruction that we all seem to be in, we know that added stress is probably being experienced by many of our students. We realize that this stress is probably being experienced by some of our staff as well. Through our Educator Health Alliance (EHA), we have access to Mental Health Resources for all of our staff. We have alerted our staff to a zoom meeting that will be conducted by personnel from EHA.

The April Board Meeting was conducted via Zoom, something that we are all hearing more about as a platform to conduct business through technology when we can't be together face-to-face. All the members agreed that they felt we were able to discuss the issues, provide input, and vote on any action items in a way that felt like a regular Board Meeting. Thanks to Marcus and Karen for helping us get the set-up down in a way that made the meeting go very smoothly. It worked so well that we will conduct the May Board meeting in a similar manner, and will wait and see what future months bring.

Architects Tim Ripp and Jeff Chadwick of Clark Enerson Partners (CEP) participated remotely in our meeting with a presentation about the progress we are making on future plans. It was pretty cool to allow them to stay in Lincoln and yet present some important summary information resulting from a meeting with our Building Committee. They assembled information on priorities identified from all of our Board Members and administrators into a phasing scheme stretching out over 15 years. Their work is really a rough draft and will get more attention at the May Board Meeting, but calls for putting some pricing information together about the costs of getting our Pre-K, 4th and 5th grades from the Cook site into the Tecumseh elementary site without jamming the students in. Again, this work is all preliminary, but looks promising as the move to one site was one of the top priorities identified by the Board and Administration. Obviously, this would not begin until the 21-22 school year with other phases following, depending on the financing climate in future years. Any changes will probably mean we would need to do a few things differently, but that would give us a year to figure out what changes would be necessary. We have been very impressed by the work and support of CEP, and look forward to staying connected to discussions about how to move forward.

We are excited to welcome Ryan Haughton back to the area as a teacher/coach, as well as Leah Phillips as a 5th grade teacher. Ryan served the Tecumseh Public Schools earlier in his career and many of you worked with him at that time. Most of you will remember Leah as Leah Tubbesing, and we are fortunate to have them join us next school year. The Board also extended a shortened contract to me (75 days) to continue supporting the move from 4 administrators to 3 during this next year. Jon has already taken advantage of the opportunity to kick me out of the office:) so you might see me wandering about if you are in the buildings. I am excited for Jon and all of you as we move forward in a pretty exciting time in the midst of uncertainty.

Having said that, we also know that the number one focus at this time is to STAY SAFE, SUPPORT OUR COMMUNITY IN OUR RESPONSE TO MINIMIZING THE SPREAD OF THE CORONAVIRUS, FOLLOW THE GUIDELINES OF THE WHO AND CDC, AND BE A PART OF THE SOLUTIONS TO THE CHALLENGES THAT WILL ARISE FROM OUR ACTIONS NOW, AND IN THE FUTURE!!!

NEWS FROM PRINCIPAL RICK LESTER

Covid-19 – I know we're all tired of the "havoc" it has brought to our Country, State, County and our school. We have had to cope with the many changes in the way we conduct learning and our daily routines. I am especially mindful of our seniors at JCC and the many senior traditions they are missing because of the current conditions in our socially distant society today.

One of the biggest traditions for seniors is the ceremony of graduation. According to the Commissioner of Education, he and the Governor advise that any "in-person" graduation ceremony or recognition is to be scheduled in late summer, July or August, and only with the approval of our local health officials. This being said, the senior class took a poll and the administration had numerous discussions on the format and what graduation date was best for JCC. Since the administration and senior class want to have some form of a traditional graduation ceremony, we thought it best to schedule Johnson County Central's graduation ceremony for the 2020 class on Saturday, July 25, 2020 at 2:00 p.m. in the high school gym.

I do have some loose ends to tie up for the end of the year and want to remind our seniors and parent of some important dates and events:

- Friday, May 1, 2020 the last day for seniors. All assignments and tests must be completed before the end of this day.
- Monday, May 4, 2020 seniors will officially check-out. Seniors will come to the high school anytime between 8:00 a.m. to 4:00 p.m. Drive in front of the high school in the circle drive, and stay in your car, Mr. Lester and Daisy will come to you. Seniors will bring iPad (cord and charger block), any uniforms, school books, library books and pay any bills to Daisy.
- Monday, May 4, 2020 senior grades are due in the computer by 8:00 a.m.
- Monday, May 4, 2020 I will verify and print senior grades and inform the Salutatorian and Valedictorian of their status.

Prom and Graduation

In an effort to allow our students to experience as many traditional activities as possible, we are rescheduling our Prom and Graduation for dates in late summer. We believe that scheduling these activities in July still honors the recommendations from the Governor and Commissioner of Education, but allows for hope that students can participate in traditional activities. Prom is scheduled for Saturday, July 18, 2020 at 8:00 p.m. at Hartman Cattle. Following the end of Prom at 11:30 p.m. Post-prom will follow. More details will be given when we get closer to dates. Traditional Graduation is scheduled for Saturday, July 25, 2020 at 2:00 p.m. in the high school gym. On Friday, July 24, 2020, seniors will have graduation rehearsal at 10:00 a.m. I will also handout report cards and other items at rehearsal. After rehearsal I will have a senior party/lunch at the 4-H building. These plans could be changed if new guidance is offered by the Governor, Commissioner, and state and local Health Officials. Any changes in these plans will be communicated at the earliest possible time.

MIDDLE SCHOOL & ATHLETIC NEWS

Parents, please check with your students and make sure they are completing their school work and participating in the regularly scheduled Zoom meetings with their teachers. Our teachers are working very hard trying to continue to provide our students with relevant learning activities through remote learning. Grades are still being entered in PowerSchool for work turned in. If your child has questions or is having is having some type of trouble, please have them contact one of their teachers or call the office. We understand this can all seem overwhelming for students and parents. There are some things parents can do to help manage expectations. Parents can make sure their children keep normal sleep hours. Don't let your child stay up all night and sleep all morning. Create a realistic schedule for getting work done in defined periods, building in breaks and times for socializing, exercising and entertainment. The key principle for students: have them do a session of work first, then have them reward them self with something relaxing. Keep in mind that it's not going to be as effective as school, but it may get to be more effective over time as everyone on the school front, as well as the home front, works to improve remote learning.

As the end of this school year approaches, we will need to start planning on students getting checked out for the summer. While details are still being worked out there are some things that students will have to take care of. Student iPads will need to be checked in during the week of May 18. Students must turn in the iPad that was checked out to them, the school-issued official Apple lightning-to-USB cable and the full 12W charger block. Insurance does not cover lost cables and chargers. If the iPad is damaged and insurance was not purchased (or you have already used your insurance claim), you will be billed the repair cost. If insurance was purchased and it has not already been used, the repair cost for any damages will be covered by the insurance. In addition to their iPads, students will also need to have all other school materials (textbooks, library books, uniforms, equipment, padlocks, etc.) turned in, and all bills, fees, and fines must be paid. Any lost or damaged items will need to be paid for. Hopefully, we will have a list of these things available prior to the checkout date. Both their school locker and their gym locker have been cleaned out and all personal items should have already been sent home. Details will be announced as we get closer to the end of the school year.

Due to the Covid-19 pandemic and the resulting strain placed on health care providers across the state, the Nebraska School Activities Association announced that pre-participation physical examinations that were given for the 2019-2020 school year will be acceptable for the 2020-2021 school year. This will be a one-year exemption only and will not include incoming freshmen. Therefore, any physical for students in grades 10-12 for the 2020-2021 school year that is on file for 2019-2020 will now be valid for the 2020-2021 school year. All incoming freshmen, along with 7th and 8th graders, would still be required to provide the school with the Pre-Participation Physical Examination paperwork that is dated no earlier than May 1, 2020. Each student, grades 7-12, who plan to participate in NSAA sponsored activities during the 2020-2021 school year will still be expected to turn in a signed Parental Consent form. The participating student and one of his/her parents or guardians must sign the certificate of consent and turn this certificate into the school office. By signing this consent form parents and students acknowledge that they understand there are risks involved in any activity. This parental consent form must be on file at school for every student who participates in NSAA activities. The NSAA Parental consent forms and physical evaluation forms for next year's 7th – 9th grades can be picked up in the office at both sites.

The Johnson Country Central Preschool Program is now accepting applications for the 2020-21 school year. The preschool schedule encompasses discovery through active involvement. "The Creative Curriculum" program is implemented and activities, materials, and equipment reflect and respect the diversity of race and multiculturalism and the physical and mental abilities of all children.

The program focuses on providing learning opportunities for those students who will be entering kindergarten the following year. Therefore, the majority of our enrollment will be filled by prekindergarten students. **Prekindergarten** is defined as a child who will be four years of age on or before July 31, 2020. A **three-year-old** is defined as a child who will be three years of age on or before July 31, 2020. Being potty trained is a requirement of the program. We offer a full-day program for prekindergarten students at both sites. Three-year-olds will join the morning of the full-day program at both sites. Preschool is in session Tuesday through Friday. There is no tuition fee for preschool.


