JCC Facilities Survey Results


(Conducted October-December 2023)

- 178 surveys were completed.
 - 16 were returned with no rank order of the options and requesting no new tax burden.
- 77% of surveys returned supported new construction.
- **PK-8 New Construction** on New Site with Gyms
 - ♦ **49% first choice**, 34% second choice, 16% last choice
- 7-12 New Construction on New Site with Gyms
 - 35% first choice, 51% second choice, 14% last choice
- Renovate Current Facilities
 - ♦ **16% first choice**, 14% second choice, 70% last choice
- Out of **2,226 registered voters** in the JCC district, the number of surveys returned represents **8.7%** of the voting population.
 - This assumes that all the surveys came from registered voters within the JCC district and that each individual returned only one (1) survey.

Recap of the July 2023 Bond Election

2,226 Registered Voters in the JCC School District:

- 66% of Johnson County Voted (Yes 636, No 537)
- **69%** of Otoe County Voted (Yes 52, No 236)
- **80%** of Nemaha County Voted (Yes 0, No 8)
- 78% of Pawnee County Voted (Yes 4, No 17)

A Historical Timeline of JCC's Facilities Journey

February 2023

- **1931** Tecumseh Site Elementary built
- 1958 Nemaha Valley School built
- 1966 Tecumseh High School built
- 1999 Addition to Nemaha Valley School through bond totaling \$3.4 million
- **2001** Due to decreasing enrollment and decreasing state aid, Nemaha Valley begins informally meeting with representatives from neighboring schools to prepare for a possible merger.
- **2003** Nemaha Valley begins a series of meetings with neighboring schools.
- **2004** In April 2004, Nemaha Valley held a public meeting to discuss the future of the district.
- **2005** In September of 2005, a feasibility study was conducted for Nemaha Valley for the possibility of a merger with Tecumseh Public Schools.
- 2007 In April 2007, joint board meetings were held between Nemaha Valley and Tecumseh Public Schools in Cook at the Nemaha Valley Media Center to dissolve the districts and merge them into Johnson County Central Public Schools. JCC's Cook Site would have programming for grades K-8, the Tecumseh Site would have programming for grades K-6 and grades 9-12.
- **2011** PK-3 programming is moved to the Tecumseh Site. All 4-8 programming is moved to the Cook Site. The Cook Site maintains a preschool as well.
- 2018 Aging facilities and staffing inefficiencies identified as areas of emphasis for the district. A series of meetings are held in the fall across the district for public input to help drive the next decisions.
- **2019** In February of 2019, Advisory Committees for Facilities and Programming are created to provide recommendations to the board for future plans. Two more community meetings are held to inform and hear from patrons.
- **2019** In April of 2019, two more community meetings were held to give patrons cost estimates for new construction.
- **2019** In November 2019, Clark Enersen Partners was chosen by the board as the architect to explore and design a future building project.
- **2021** In January 2021, JCC entered into an Option Agreement to Purchase Real Estate for the 52 acres of land North of the Tecumseh Site football field for a potential new site.
- **2021** In October 2021, JCC contracts with Boyd Jones as the Construction Manager At-Risk for a future building project.
- **2022** A bond election for a PK-12 facility on new ground in the bond amount of \$43.375 million dollars fails on a vote of 563 FOR and 673 AGAINST.
- **2023** A bond election for a PK-12 facility on new ground in the bond amount of \$49.5 million dollars fails on a vote of 692 FOR and 798 AGAINST.

Clarification on Figures from the November 2023 Newsletter

February 2023

In my November 2023 newsletter article titled "One Site Benefits", I talked about personnel savings and time lost for teachers due to travel. Here is the excerpt from the article:

"Up to 7 class periods are lost due to 8 teachers traveling between the 2 sites on a daily basis (this equates to a full teacher or approximately \$74,200)."

The number \$74,200 is the average cost to the district for a teacher based on the salaries and benefits of teachers at JCC for the 2023-2024 school year. \$74,200 includes salary **and** benefits. The current base salary for teachers at JCC is \$39,400 without benefits. The current highest salary paid to JCC teachers is \$75,254 without benefits.

Kindergarten Enrollment

For the 2024-2025 School Year

Students reaching age 5 on or before July 31, 2024 are eligible for kindergarten for the 2024-2025 school year. We will be setting a date for Kindergarten Round-Up soon. Please stay tuned for updates.

Students who will reach the age of 5 between August 1 and October 15 this year, can be enrolled for the 2024-2025 school year. However, the student must demonstrate through JCC's recognized assessment procedure that they are capable of performing the work of kindergarten. JCC School Board Policy 5055 states:

"The board delegates to the elementary principal responsibility for determining whether the conditions of this policy have been met. The elementary principal may deny early enrollment of a child who meets the early enrollment criteria if, in the principal's professional judgment, the child lacks the academic or social skills to be successful in the district's kindergarten program."

Early enrollment requests for the 2024-2025 school year must be submitted by March 29, 2024.

Snow Days

(How many days can the students miss?)

Due to January's exceptional weather conditions, JCC (and many other schools) had to cancel some school days. These decisions aren't easy as we know we'd like to have the children in school (And some of you would love to get them out of the house!), but the safety of staff and students is the biggest concern. Can our buses traverse the roads safely? Can those parents, students and staff driving to school and back do so safely? Can those who walk to school make it safely? Input from several people and agencies are used to make the decision:

- County roads departments are consulted.
- Attend webinars and get updates from the National Weather Service.
- Get updates from Pawnee/Johnson County Emergency Management.
- Get updates from JCC transportation personnel who (when safe to do so) drive out and check the bus routes.
- Personally drive county roads to check conditions.

As we have a considerable amount of winter left this school year, we can't help but wonder how many school days can the students miss before they have to make it up? The short answer is 11 days for high school students, nine days for middle school and 14 days for elementary. The long answer has to do with the state requirements for student hours and the length of our school day. High school and middle school students are required to attend 1,080 hours each year while elementary students are required to attend 1,032 hours each year. The JCC school day is 6.97 hours for high school, 6.87 hours for middle school and 6.8 hours for elementary school. All of these take out time for lunch. These numbers are then multiplied by the number of full school days (165) and then two half days (the first and last days of the school year) are added on. This puts the totals at 1,157.55 hours for the high school, 1,141.05 for the middle school and 1,129.5 for elementary. Take the total number of hours, subtract what is required by the state, divide this by the length of the school day, and you will get the number of days over what is required.

High School (1,157.55 - 1,080) / 6.97 = 11.1 days over requirement
 Middle School (1,141.05 - 1,080) / 6.87 = 8.89 days over requirement
 Elementary (1,129.5 - 1,032) / 6.8 = 14.3 days over requirement

NEWS FROM PRINCIPAL RICK LESTER

The month of February is our first step in preparation for next fall where our students will start pre-registration for the 2024-2025 school year.

What is pre-registration? The students choose their top eight classes and two options - at this time there is no set schedule. Once all pre-registrations are complete we'll plan the class schedule. Every student must sign their pre-registration form and their parents must also sign the form. This gives the parents the opportunity to see their student's class selections and "sign off" on it. Mrs. Reuter, the school counselor, is the final signature on every student's pre-registration form. She reviews each student's class selection to verify they are taking appropriate classes which are required for each grade and are meeting their graduation requirements.

Students will receive their pre-registration forms on Wednesday, February 14, 2024. They will be due back to the office on Wednesday, March 13, 2024. This due date is necessary so that we can plan the class schedule. We try to create a schedule that accommodates the most students with the least amount of conflicts. Once we have the best class schedule created, Mrs. Reuter will personally meet with each student who has a class conflict. A student will only have a class schedule conflict if they are unable to get an eight period class schedule by using their eight selected classes or two options. Mrs. Reuter will then aid them in selecting an additional alternate class until we are able to fill their eight periods with an appropriate schedule.

After we have completed a successful class schedule, I will send out summer pre-registration letters to all students. Around the first week in August, each student will receive this letter which will contain their actual class schedule, complete with periods and teachers for every class. If the students and parents are satisfied with this schedule, nothing more needs to be done before the beginning of school next fall. If students desire to make changes to their class schedule they will have a scheduled day (to be announced), to meet with the counselor to make changes prior to the start of school. Students will also have the first five days of the 2024-2025 school year to change their class schedule.

I encourage all parents to work with your students to help them plan their 2024-2025 class schedule - your input and encouragement is essential.

FAFSA Update and How to Create an FSA ID

The 2024-25 FAFSA is now open!!!! Students and parents must create a Student Aid Account (FSA ID) – including parents without a Social Security number.

- If parents file as married filing jointly only one parent FSA ID is required.
- If parents are unmarried but live together or are married and filing taxes separately, both parents must have an FSA ID.
- The Social Security Administration must verify the FSA IDs *before* a FAFSA can be started (allow 3 days)
- FSA IDs will use two-factor authentication.
- Those without a Social Security Number will be able to create an account when the FAFSA opens.

EducationQuest provides free help to Nebraska families!!! Their college planning experts are also ready to provide personal assistance in person at their offices, through a Zoom meeting, or on the phone. Applications for Susan Thompson Buffett Foundation Scholarships Open Until Feb 1st

The Susan T. Buffett Foundation has offered scholarships to college students in Nebraska for over 50 years. Scholarships are awarded on a competitive basis to first-time freshman entering college who live in Nebraska, graduate from a Nebraska high school with plans to attend a Nebraska public college, and demonstrate financial need. The requirements for the online application are as follows: application forms, one recommendation, FAFSA Submission Summary (previously called Student Aid Report), high school transcript, short answer questions, and a consent form. All applications must be submitted including all required documents by February 1, 2024 before 5:00 PM (central time), except for the FAFSA Submission Summary. Your FAFSA Submission Summary needs to be submitted by March 15, 2024 before 5:00 PM (central time). There are no exceptions on deadlines, none whatsoever!

JCC Preschool Enrollment for the 2024-25 School Year Opens February 1, 2024

We know you are your child's first and most important teacher, and we would love to join you in the education of your young learner.

Our focus is to provide learning opportunities for those students who will be entering kindergarten the following year. Therefore, the majority of our enrollment will be filled by prekindergarten students. **Prekindergarten** is defined as a child who will be four years of age on or before July 31, 2024. A **three-year-old** is defined as a child who will be three years of age on or before July 31, 2024. We offer a full-day program for prekindergarten students. Three-year-olds will attend a morning preschool session. All preschool programming will be housed at the Tecumseh site for the 2024-25 academic year. Preschool is in session Tuesday through Friday. It is preferred that your child be fully toilet trained before entering the program. If your child is kindergarten eligible (age five by July 31, 2024), he/she is <u>not</u> eligible for our preschool program.

The preschool schedule encompasses discovery through active involvement. "The Creative Curriculum" program is implemented. Activities, materials, and equipment reflect and respect the diversity of race and multiculturalism and the physical and mental abilities of all children.

There is no tuition fee for preschool. However, breakfast and/or lunch fees will be charged when applicable. An application for free and reduced meals will be offered at orientation.

Transportation will be provided to and from <u>licensed</u> child care programs at no cost. Shuttle services will run between the Cook site and the Tecumseh site.

Enrollment will be filled according to the following criteria: Rule 11 guidelines, students currently enrolled in our program, and the date an application is received. If interested in the preschool program, please complete the electronic application which will be available beginning **February 1, 2024** on the school website: www.jccentral.org. If you would prefer a paper application, please contact the elementary office.

Contact will be made by April 15, 2024 regarding enrollment for the 2024-25 school year. If you have any questions or would like to schedule a classroom visit, please call the **elementary office:** 402-335-3320. Thank you for considering Johnson County Central Preschool.

*All preschool children, regardless of their abilities, disabilities, or the social, linguistic, or economic diversity of the children's families are eligible to be served in our preschool program.
